

CATTERLEN PARISH COUNCIL MINUTES. 94

A Meeting of the above Council took place on Wednesday 25th June 2025 at 7.30pm in the Village Hall. Newton Reigny.

PRESENT. Councillors. A. Blackburn. Chairman. K. Monaghan. D. Booker. C. Wright. and the clerk. F. P. Barbour.

APOLOGIES. Were received from Cllr. J. Elliott.

MINUTES of the last Meeting, and Site Visit were approved and signed by Chairman. A. Blackburn.

MATTERS ARISING. The defibrillator is now in position in the redundant Newton Reigny Telephone Box, and is awaiting verification with NHS. With regard to the SID project, and provision of Catterlen Village gates. W.& F.C Highways has finally given permission to proceed. Letters sent to property owners in Newton Reigny with regard to overhanging bushes on to highway, and footway, have resulted in no response. The clerk was instructed to inform Highways dept.

CORRESPONDENCE A letter concerning the transfer of ownership of Parish Street Lights. It was agreed to transfer ownership to W & F. C. Information was received regarding 2025/26 W&F.C investment in Highway improvements. 19.9 Million pounds. An invitation to apply for 20 mph speed restriction was declined. A request for Grant Aid from the Nichol's Memorial Hall was approved in the sum of £700. A request from St. John's Parochial Council for assistance with costs of removal of mature tree, causing churchyard wall damage. It was agreed to grant aid £500.

The clerk agreed to Email all Parish Councillors with details of a forthcoming Teems Meeting regarding duties, and conduct of Members and Officers of Parish Councils.

PLAY AREA. Following a period of restricted access to the Amenity / Play Area. The complex Play Structure required extensive repair, which was promptly carried out at cost of £1196..08 a cheque in that sum was completed accordingly.

ACCOUNTS. The clerk presented the Y. E 31/03/2025 internally audited accounts as Completed by ASAP Accountancy Services. These were fully approved and signed for submission to the National Audit.

HIGHWAYS. The ongoing issue of water emitting from the original Pinfold Watering Point is causing flooding in the Parish Council Owned Pinfold Garden and on to the Highway with potential traffic hazard. The clerk was instructed to write to Balmacwyn CA11 0AY with respect to this problem.
